This qualification reflects the role of individuals working in an operational role in civil construction, who undertake a prescribed range of tasks using limited practical skills and fundamental knowledge in a defined context working under supervision.

Occupational opportunities in the civil construction industry include:

- Civil construction general hand
- Earthmoving plant operator
- Construction labourer civil
- General hand

This certificate allows individuals to develop practical skills in the following areas:

- identifying, locating and protecting underground services
- measurements and calculations
- manual excavation
- levelling
- reading and interpreting plans and specifications.

Safely use and maintain tools and equipment used in civil construction, including:

- hand and power tools
- small plant and equipment
- concreting materials and equipment.

Develop skills and knowledge required to work safely and follow WHS policies and procedures in the Resources and Infrastructure Industries. Government subsidies for training programs vary by State an Territory jurisdictions. Government subsidised training places are generally available to those without a qualification up to a Certificate III level especially for those referred through an Employment service provider.

There may be subsidies available to employers to support the cost of training to their Employees. Employers are usually expected to contribute to the cost of training.
